### **Points of Emphasis:**

1. All participants need to complete a Release of Liability Waiver. The team coach should always keep a copy with them during play.



### **RULE & PROCEDURE SIMPLIFICATION GUIDELINES**

The 2022 AJV season will be governed by the National Federations of High School Playing Rules and Procedures. The AJV has simplified all rules and procedures to allow for a better basic understanding by all teams, coaches, event managers and hosts.

#### I. Playing Rules:

#### 1. SERVING:

Each server will have five seconds to serve the ball. For a bad toss, one re-serve is permitted during each service attempt.

#### 2. NET FAULTS:

Contact by any player with the net is a violation.

#### 3. CENTERLINE FAULTS:

A player's complete foot / hand must be completely across the centerline before a fault is called. Any other body part across the center line is a fault.

#### 4. BALL HANDLING VIOLATIONS:

All obvious catches, carries or throws of the ball is a violation. If you can say, as the referee, that was ugly then call the violation. **Note:** In all divisions **14 & under double hits will be considered legal** and should not be called.

#### 5. BALLS:

Teams shall provide balls for warm-ups and matches. Divisions 12 and under must use a volleyball lite.

#### 6. COIN TOSS:

The team that appears first on the schedule will call the coin toss. The winner of the coin toss has choice of serve or receive. There are no coin tosses for the third set. The team that served first in set one will serve first in set three.

#### 7. TIME OUTS:

Each team will be allowed two-time outs per set. Time outs are 30 seconds and will be timed by the scoring table.

#### 8. TEAM BENCH AREA:

Teams will occupy the same bench area throughout the match.

#### II. 12'S PLAYING MODIFICATIONS

- 1. Teams shall provide a volleyball-lite for play.
- 2. Each server shall be allowed three consecutive serving points during a term of service. After the third serving point the opponents shall be awarded the ball to serve.
- 3. The serving line will be measured 24 feet from mid-court. There is no service foot fault.
- 4. The net height will be 7.

#### **III. OFFICIATING REQUIREMENTS:**

- 1. Teams are responsible for providing:
  - a. A first referee (R1) (must be team coach or an adult) and a second referee, (R2). In the 12 and Under division a R2 is not required. The R2 will only call centerline and net violations.
  - b. Two-line judges positioned at opposite left back corners.
  - c. A scorekeeper, score flipper /timer. Time is responsible for timing warm-up periods and time outs. (Recommended Parent Assistance for 14 & Under Divisions)
  - d. Officiating assignments will be noted on playing schedules.
  - e. Libero trackers will not be used.
- 2. The referee or scorekeeper will monitor time out periods.
- 3. The referee or scorekeeper will monitor the three-minute time period between sets.

#### IV. MATCH PROTOCAL

#### 1. WARM-UPS:

- a. Pre-match warm-up time frames is noted on the playing schedules. (See page 9.)
- b. The team that appears first on the playing schedule (home team) will take the court to the left of the scorer's table and the team that appears second on the schedule (visiting team) will take the court to the right of the scorer's table. **Teams will occupy the same bench area throughout the match**.

#### 2. STARTING LINE-UPS & TAKING COURT:

- a. Players <u>will not</u> line up at the end lines before the match. Players go straight onto the court and play. The traditional sportsmanship handshake will be taken after the match.
- b. The coach will be responsible for placing their players in *proper service rotation* at the start of each set.
  - i. Line-up sheets will be at the scorer's table or see page 4.

#### 3. SUBSTITUTION PROCEDURE:

- a. Substitutions *will not* be recorded by the scorekeeper or conducted by the second referee.
- b. The <u>coach must enter the substitution zone</u> <u>with player(s) substituting.</u> The referee will recognize the substitution when players and substitute(s) are in the substitution zone.
- c. The substitution zone is the area on your side of the court between the net and the 10' line.
- d. Liberos will exchange / replace freely.

**VENUES:** Hermantown Middle School, Hermantown

Hibbing High School, Hibbing

**EVENT INFORMATION:** Team reps and coaches are responsible for all event information and procedures.

• Teams are to report to their assigned court **no later than 20 minutes** prior to the 1st Match start time.

• The event manager **(EM)** will conduct a quick review meeting. See page 6 for time and location.

Teams that are scheduled to play the 2<sup>nd</sup> match of pool play do not need to attend the quick review meeting, but must check in with the **(EM)** upon arrival.

**LIABILITY FORMS:** Coaches must present completed player liability release forms to the (EM) at the Quick Review Meeting.

No form, no play. Coaches are to keep a file of liability release forms with them at all times.

**TIME LIMITS:** There will no time limits on match play, unless necessary due to facility constraints.

**POOL PLAY DEFUALT:** If a team does not show as scheduled, the pool will be re-formatted (defaulted) to a 6, 5, 4, or 3 team pool.

If revisions need to be made the day of play, pools will then default to the appropriate pool play schedule.

COURT SIDE READINESS: The on-deck team. Teams that play or officiate in a succeeding match must be at courtside mid-way

through the second / third set of the current match.

**OFFICIATING:** Simplified Officiating / Scorekeeping. (See Page Two)

PLAYING RULES & PROTOCOL: Simplified Rules and Protocol. (See Page Three)

**DEAD BALL HUSTLE:** (DBH) Players hustle the ball when it is dead or out of bounds.

**BALLS:** Teams must provide balls for warm-ups and match play.

**TEAM CAMP AREAS:** Teams <u>must</u> clean their camp area before leaving the facility.

**SPECTATOR SEATING:** Will be designated by host.

**FOOD POLICY:** Teams are prohibited from eating in the gym. Water bottles only.

Coolers are not allowed in buildings.

**ADMISSIONS:** \$6.00 Adult & Student. 6 and Under Free.
